

Augustana College COVID Alert Levels

As we resume operations under the COVID-19 mitigation efforts outlined in Augustana Strong, it is important that our community is aware of the factors that the College will consider in assessing the risk presented by COVID-19.








The College will operate under one of four alert levels: Level 1- Low Alert/New Normal, Level 2- Moderate Alert, Level 3- High Alert, and Level 4 – Very High Alert. Movement between these alert levels will be informed by the indicators listed below, including the positivity rate on campus and in Rock Island County, the number of new cases, the College’s ability to link new cases to known cases, and the continuous ability to quarantine and isolate where necessary. Also identified in the chart below are other factors that will inform the College’s determination of the alert level. Of course, these factors and the operational impact of any particular level may be modified as new information, best practices and experience warrants.

The College Cabinet will monitor these factors on a frequent basis, and will determine movement between alert levels. Consultation with public health experts will continue, and any movement to Level 4- Highest Alert will include the Augustana College Board of Trustees. Changes in alert levels will always be informed by both the data and by the College’s judgment of current conditions. It is also important to understand that the College may, in response to a specific indicator or indicators, increase the operational restrictions in a particular area or areas to a higher alert level without moving to that higher alert level for all operations. This will allow for more targeted responses to current conditions and the COVID-19 risk they present. Augustana Community members must be prepared, however, to move to a higher alert level with little advance notice.

We are beginning the academic year at a Level 2/Moderate Alert level. We have numerous mitigation strategies in place for this level as outlined in “Augustana Strong,” some of which have been updated even since its August 10, 2020 publication.
